

## ***Privacy statement***

We only utilise personal data (hereinafter referred to generally only as "data") within the scope of the necessity as well as for the purpose of providing a functional and user-friendly website including its content and the services offered there.

In accordance with Section 4 Number 1. of (EU) 2016/679, the European General Data Protection Regulation (hereinafter referred to as the "GDPR"), "Processing" is any operation or set of operations which is performed on personal data or on sets of personal data whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or other provision, alignment or combination, restriction, erasure or destruction.

In the following privacy policy, we will inform you, in particular, about type, scope, purpose, duration and legal basis of the processing of personal data as far as we decide on the purposes and means of the processing either alone or jointly with other parties. In addition, we shall inform you about the third-party components used for optimisation purposes and also to increase the quality of use, insofar as third parties process data on their own responsibility.

### ***I. Information about us as a responsible party***

### ***II. Rights of users and affected parties***

With a view toward the data-processing described in greater detail in the following, the users and affected parties have the right

- to confirmation as to whether or not their personal data is processed, to information about the data processed, to further information about the data processing as well as to copies of the data (see also Section 15 of the GDPR);
- to correction or amendment of incorrect or incomplete data (see also section 16 of the GDPR);
- to immediate deletion of the respective data (see also Section 17 of the GDPR), or, alternatively, in so far as further processing in accordance with Section 17 Paragraph 3 of the GDPR is required, to restriction of the processing in accordance with the provisions of Section 18 of the GDPR;
- to obtain their personal data and the data they have provided and to transfer this data to other providers/responsible parties (see also Section. 20 of the GDPR);
- to submit a complaint to the supervisory authority if they are of the opinion that their personal data is processed by the provider in breach of data protection law (see also Section 77 of the GDPR). A responsible supervisory authority is the Data Protection Office of Bavaria, Wagnmullerstrasse 18, 80538 Munich, Germany. However, the user may choose any other supervisory authority.

Furthermore, the provider is obliged to inform all recipients, to whom the data is disclosed by the provider, of any correction or deletion of data or the restriction of the processing on the basis of Articles 16, 17(1), 18 of the GDPR. However, this obligation shall not apply if this communication is impossible or would involve disproportionate effort. Notwithstanding the foregoing, the user has a right to information about these recipients.

**In accordance with Section 21 of the GDPR, the users and affected parties also have a right of appeal against the future processing of their respective data, provided that the data is processed by the provider in accordance with the provisions of Section 6, Paragraph 1, Letter f) of the GDPR. In particular, an objection to the data processing for purposes of direct marketing is permissible.**

### **III Information about data processing**

The data processed during your use of our website will be deleted or blocked as soon as the purpose of storage no longer exists, the deletion of the data is not prohibited by statutory retention obligations and subsequently no other information regarding individual processing procedures has been provided.

## **Server data**

For technical reasons, particularly with a view toward ensuring a safe and stable website, your Internet browser sends data to us or to our web space provider. These server log files record, among other things, the type and version of your internet browser, operating system, the web site from which you have come to our website (referrer URL), the website(s) of our Internet presence that you visit, the date and time of each access as well as the IP address of your internet connection our website is used.

The data collected will be stored temporarily but not together with any other data from you.

This data is processed on the legal basis of Section 6, Paragraph 1, Letter f) of the GDPR. Our legitimate interest lies in the improvement, stability, functionality and security of our internet presence.

The data will be deleted after seven days at the latest unless further storage is required for evidential purposes. Otherwise, the data shall be completely or partially exempt from deletion until the final clarification of an incident.

## **Contact enquiries/contact option**

In the case of inquiries by mail (mandatory information: name, address, message) or telephone (mandatory information: name, telephone number, message), contact form or e-mail (mandatory information: name, phone number, message), we collect your contact information as far as it is required for processing and lock this information after processing the request.

If contact is made at trade fairs or events, we save your contact data, (mandatory information if contact by mail is requested: name, address, in the case of contact via e-mail: e-mail address, in the case of call-back via phone: name, telephone number) in order to inform you about new offers and events, provided you agree to the storage of the data.

If you use the contact form or e-mail to contact us, the data you provide will be used to process of your request. The data must be provided in order to process and respond to your inquiry - If this information is not provided, we cannot respond to your inquiry or all may only be able to respond to a limited extent.

The legal basis for this processing is consent in accordance with Section 6, Paragraph 1, Letter a) of the GDPR.

Your data will be deleted after your request has been conclusively answered and the deletion is not prohibited by statutory retention obligations such as in the case of a subsequent execution of a contract.
